SEEDS Member Information

Statement of Intent (who we are):

SEEDS San Diego (*Sending Economic Encouragement to the Distressed*) is a giving circle of Christian women, agreeing upon a statement of faith, dedicated to helping those in physical, emotional, and spiritual need in San Diego and abroad, who are financially capable of giving \$500/\$1000 a year for 3 years, with unlimited yearly renewals.

Vision Statement (what we will see):

Women engaged in giving, exposed to, and involved in, what God is doing around the world.

Mission Statement (why we exist):

To provide the means by which caring women are encouraged to give to those in need in the name of Jesus Christ.

Purpose Statement (how we do what we do):

By pooling our finances as a giving circle, we are able to more deeply impact evangelical Christian nonprofits that minister to those in physical, emotional, and spiritual need in San Diego County and abroad.

- Our giving circle eliminates frequent meetings and fund-raisers, etc. Via a simple yearly donation of either \$1000 or \$500, we pool our resources and give all our money away to two evangelical Christian nonprofit ministries—one in and around San Diego County and one overseas—that serve those in need in the name of Christ.
- We have a fall meeting to kick off our next season of giving, and a spring meeting to meet the representatives of the ministries in which we're interested (especially those we can't cover in local site visits). Our 6-member board chooses the slate of ministries; all members vote anonymously for the winners. Voting is in the spring.
- All our donations are handled by the National Christian Foundation, which, as a donor-advised fund, invests our funds and sends out our checks according to our directive. As a result, we have no overhead charges and all donations (except for the slight handling fee from NCF) go directly to the ministries we choose.
- SEEDS San Diego is a ministry of High/Ground, a 501(c)(3) nonprofit since 1987 (www.high-ground.org).

Statement of Faith

We believe:

Member Requirements

Requirements and Responsibilities for the Members of SEEDS:

- Willing and able to commit to giving \$1000 or \$500 yearly, for a three-year term with encouragement to continue year by year
- Agreement with Member Pledge by signature
- Reading of Statement of Faith
- Participating by voting every year and by attending site visits as able
- Attendance, if possible, at our 2 meetings, one in the fall, one in the early spring

Members may be asked to resign for

- a. Non-payment of pledges
- b. Unduly influencing other members toward a specific vote

- When your donation is received by the National Christian Foundation (donation due by March 15 every year), you will receive a tax deductible receipt from NCF on behalf of SEEDS.

Member Pledge

I support the stated purpose of SEEDS San Diego to be a Christ-centered giving circle that will direct financial gifts to selected evangelical Christian nonprofit ministries that serve those in need. I have read SEEDS' Statement of Faith.

As a Member, I pledge \$1000 yearly for three years; as an Associate Member, I pledge \$500 yearly for three years. After meeting that commitment, I may continue on a yearly basis. I understand my pledged donation will be paid to the National Christian Foundation by March 15.

I understand that, as with all donor advised funds, all SEEDS contributions are the property of NCF and are nonrefundable, and that NCF will disburse our gifts as recommended by SEEDS.

I recognize that in addition to my financial pledge, I can also participate in SEEDS by committing to prayer, by volunteering my services, by recommending nonprofits to receive gifts, and by going on site visits.

I agree that the SEEDS Leadership Committee will make the final decision of where to direct our gifts, based upon partnership votes, the careful review of applicant qualifications, site visits when possible, and by the further vetting on our behalf by NCF.

I agree that the direction and management of SEEDS and entire control of its affairs shall be vested in the SEEDS Leadership Committee, as a ministry of High/Ground.
